Members of the Boise Angel Alliance invest directly in local companies. Accredited investors may apply for Boise Angel Alliance membership. Annual dues are \$1000.00. You may join by completing an application and sending it to our mailing address along with your check payable to the Boise Angel Alliance, Inc.

The Boise Angel Alliance and Boise Angel Fund, LLC members meet on the third Tuesday of each month (except March, July, August and December) at 5:00pm to review investment opportunities, discuss trends and best practices in private investing, hear updates on local investing activities and enjoy food and refreshments in a relaxing yet professional and private environment.

### ***How does it work?***

Companies seeking early stage investment submit a joint application to the Boise Angel Alliance and the Boise Angel Fund, LLC. Members evaluate the candidate companies to determine if a presentation to the entire membership is appropriate based on screening criteria.

### ***BAA members make their own independent investment decisions.***

After due diligence on a selected company, an investment term sheet is negotiated with the company management. The Boise Angel Alliance members (individually) and the Boise Angel Fund, LLC members (as a group) make a determination to invest in accordance with the negotiated investment term sheet

### ***What is in it for you?***

More and more angel investors are forming angel investor groups to:

- Improve deal flow
- Share expertise
- Distribute workload
- Diversify risk
- Improve company success and investment results.

Boise venture capital firms have received hundreds business plans from Boise area entrepreneurs. Many of these companies were too early in their development for institutional investment, but were great opportunities for angel expertise and seed stage investment.

Angel investing is one of the most significant economic engines in the United States economy. In 2006, angel investors in the United States helped fund and guide over 50,000 emerging companies with capital of \$26 billion dollars, approximately the same amount as invested by venture capitalists. Angel investors are responsible for starting 90% of Inc. Magazine's 100 Fastest Growing Companies each year.
